Fire Department Report:

- 1. Chief Tony Matthews reported.
 - a. This year, 2020, there were 417 total calls to date
 - b. Down on fires to 41, EMS Assists up to 194
 - c. 45 Vehicle accidents
 - d. 65 service calls
 - e. First responder program enables increase with EMS calls
 - f. 28 active personnel, 12 EMS certified, 16 NC Certified Fire Fighters
 - g. Replaced aipracks, this will be an ongoing process.
 - h. Santa will be parading December 12.
 - i. Vehicles are up to par, holding well.

EMS Report:

- 1. Chief Melinda Ward reportedRough start to the year with loss of staff.
 - a. Full time 6, with 3 paramedics, few PRNs.
 - b. COVID has been an issue but not as many cases as other parts of the county.
 - c. Call Volume is up, mostly due to COVID

Committee Reports:

- 1. Tony Bello, Bylaws Committee Chair, distributed proposed amendments and Policy and Procedures manual.
 - a. Questions were asked concerning clarification on the amendment of Fire Department officers not eligible to serve as President, Vice-President, Treasurer, and Secretary on the Board of Directors. Tony Bello confirmed that was a presented amendment due to a conflict of interest between board officers and fire department officers.
