- 1. Treasurer Jeff Batten presented the Treasurer's Report and financial statements:

 - b. We need to submit financial records to our CPA for review and submit our budget to the county in the upcoming months.

- 1. President Tony Bello presented his reported:
 - a. 2022 has been a very productive year for the Broad & Gales Creek Community Association. I have been working with board officers and committee chairs as they serve the community with their important tasks. There have been many changes made that will better the community as we grow with new residents.
 - b. Last year, we were awarded a \$23,000.00 Big Rock Tournament Community Grant for new playground equipment and a new basketball court. We have applied this year for additional grant funds to purchase more playground equipment for our community park.
 - c. As of July 1, 2022, Broad & Gales Creek EMS Inc. has relinquished EMS services to Carteret County Emergency Management. The county now leases the east end of the building for EMS services that they provide for our district. Due to this change, there will be a vote on bylaw amendments pertaining to the EMS chief position on the board of directors for the Broad & Gales Creek Community Association. We look forward to working with the County Emergency

Management Services as we move forward in providing the best EMS services possible for our community.

- d. We have partnered with Compassion Ministries as they provide outreach services for our community from within the community building. They also operate the "Compassion Closet" the to provide clothing, home goods, and toys for community members in need. This past year, the association turned over the Gordon Salter Memorial Cemetery to Compassion Ministries to better serve the residents of the Broad & Gales Creek Fire District. Thank you to Sallie Salter for all her hard work and dedicated service to our community.
- e. I have been working with Treasurer Jeff Batten to streamline banking, payroll, and financial responsibilities for the fire department and community association. Our bookkeeper, Alison Bentz, has done a tremendous job working with Jeff Batten as we transition to a more streamlined process of conducting financial business and working productively with our CPA.
- f. I have also been working with Steve Phifer, Building and Grounds Committee Chair, to oversee the community building, park, and fire department properties. Steve has done a great job with maintaining the building and grounds for all association properties.
- g. I look forward to working more with the dedicated community members in providing a safe and inviting community within our fire district. I would like to personally thank all the volunteers of the Broad & Gales Creek Fire Department and Chief Tony Matthews for his extraordinary ability to manage the day-to-day operations.

 - f. Fall Festival, Take a kid to school in a fire truck fundraiser.
 - g. We will be specking out a new truck next year.
 - h. iPad tablets were installed in the trucks for updated communications.
 - i. Looking for Conex boxes to convert into a burn house for training.
